## General Landfill Information:

- MSW/Garbage is not accepted at this location
- Payment sources include cash or check only, no debit or credit cards accepted

## Frequently Asked Questions:

- **I live in a rural area, how do I dispose of my household garbage now that the landfill no longer accepts it?** You may either contact a commercial waste hauler for a dumpster or you can "self-haul" to the Redwood/Renville Regional Material Recovery Facility (MRF) located in Redwood Falls.
- **What is clean demolition material?** Clean demolition is general construction demolition material that **does not** include ANY: Plastic (film, bags, binding straps, tubes, etc.), clothing, chemical material (caulking, adhesives, liquids (tube or solid)), food and beverage waste (can, bottle, bag, wrappers), appliances or electronics, general garbage, yard or household wastes, etc. (**See website for a list of acceptable demolition materials**).
- **Are automobile and agricultural tires still accepted?** Yes, please see inside the brochure for pricing.
- **How can I dispose of scrap metal?** A roll-off container is on-site to take various types of scrap metal, such as: bicycles, duct work, fence posts, iron pieces, angle iron, culvert pipes, grills (gas/charcoal), push/riding mowers, etc. For large metal items such as automobile and tractor hulks, please contact or ask for a list of local salvage yards.
- **As a rural resident, can I still drop off my recyclables?** Yes, a recycling container is available for any rural resident who would like to deposit their recyclables (during business hours).
- **Do you accept asbestos at the Landfill?** No, please call Spruce Ridge Landfill located near Hutchinson, MN.

- Fluorescent or LED Light bulbs
- Ballasts (must be removed from light fixture)

## Items NOT Accepted

- Sharps Needles, lancets & syringes

- Radioactive Materials

- Electronics & Appliances - **watch for public announcements of the electronic and appliance recycling days offered by S.W. Inc.**
- Empty containers of any type - Garbage/trinkets/baskets/junk of any kind mixed in with the HHW Material.



## What is Household Hazardous Waste (HHW)?

Household products that can present a hazard to our health and our environment when not properly used, stored, or disposed of, are considered Household Hazardous Waste.

The Renville County HHW Facility accepts hazardous materials from both Renville and Redwood County residents for **NO CHARGE**. **Hazardous business waste cannot be accepted.**

## Transporting HHW

- Keep products in their original containers
- Do not mix products
- Make sure lids are sealed tightly
- Label materials if original label is missing or unreadable
- Keep flammables out of direct sunlight and away from sources of heat, spark, flame, or ignition
