

AN ORDINANCE REGULATING THE USE OF HIGHWAYS WITHIN THE CITY OF LAMBERTON, INCORPORATING PROVISIONS OF THE STATE HIGHWAY TRAFFIC REGULATION ACT, MINNESOTA DRIVERS LICENSE LAW, AND THE MINNESOTA TITLE AND REGISTRATION ACT BY REFERENCE, AND IMPOSING A PENALTY FOR THE VIOLATION THEREOF.

The Council of the City of Lambertton ordains:

SECTION 1. MINNESOTA TITLE AND REGISTRATION ACT INCORPORATED BY REFERENCE. The regulatory provisions of Minnesota Statutes, Ch. 168, as amended, are hereby adopted as a traffic ordinance regulating the registration of motor vehicles on the highways, streets, alleys and City owned property of the City of Lambertton and are hereby incorporated in and made a part of this ordinance as completely as if set out here in full, except as hereinafter changed or modified.

SECTION 2. HIGHWAY TRAFFIC REGULATION ACT INCORPORATED BY REFERENCE. The regulatory provisions of Minnesota Statutes, Ch. 169, as amended, are hereby adopted as a traffic ordinance regulating the use of highways, streets, alleys and City owned property of the City of Lambertton and are hereby incorporated in and made a part of this ordinance as completely as if set out here in full, except as hereinafter changed or modified.

SECTION 3. MINNESOTA DRIVERS LICENSE LAWS INCORPORATED BY REFERENCE. The regulatory provisions of Minnesota Statutes, Ch. 171, as amended, are hereby adopted as an ordinance regulating the licensing of persons driving motor vehicles upon the streets, highways, alleys and City owned property of the City of Lambertton and are hereby incorporated in and made a part of this ordinance as completely as if set out here in full, except as hereinafter changed or modified.

SECTION 4. PENALTY. Any violation of the statutes adopted by reference in Sections 1, 2 and 3 is a violation of this ordinance when it occurs upon the highways, streets, alleys and City owned property of the City of Lambertton. Any person thus violating any provisions of this ordinance shall be guilty of such offense and shall be punished by such penalty as is prescribed by such statutes.

SECTION 5. REPEAL. Ordinance No. 124, entitled "An Ordinance Regulating the Use of Highways within the City of Lambertton," is hereby repealed.

SECTION 6. PRESERVATION OF RIGHTS. Except as provided by M.S.A. 169.89, Subd. 3, the repeal of any ordinance or portion thereof by the preceding section shall not affect or impair any act done or right, vested or accrued, or proceeding, suit or prosecution, had or commenced, shall remain in full force and effect to all intents and purposes as if such ordinance or part thereof so repealed or altered by the City of Lambertton, shall be discharged or effected by such repeal or alteration; but prosecutions and suits for such offenses, liabilities, penalties of forfeitures shall be instituted and proceeded with in all respects as if such prior ordinance or part thereof had not been repealed or altered.


SECTION 7. EFFECTIVE DATE. This ordinance shall take effect from and after its adoption and publication.
