AN ORDINANCE NAMING AND RENAMING PUBLIC STREETS AND THOROUGHFARES

The Village Council of the Village of Lamberton, Minnesota, do ordain as follows:

- Section 1: U.S. Highway No. 14 Broadway. That that part of U.S. Highway No. 14 lying and being within the village limits is hereby designated and named Broadway.
- Section 2: First Street First Avenue. That the street heretofore designated and known as First Street is hereby designated and renamed First Avenue.
- Section 3: Second Street Second Avenue. That the street heretofore designated and known as Second Street is hereby designated and renamed Second Avenue.
- Section 4: Third Street Third Avenue. That the street heretofore designated and known as Third Street is hereby designated and renamed Third Avenue.
- Section 5: Fourth Street Fourth Avenue. That the street heretofore designated and known as Fourth Street is hereby designated and renamed Fourth Avenue.
- Section 6: Fifth Street Fifth Avenue. That the street heretofore designated and known as Fifth Street is hereby designated and renamed Fifth Avenue.
- Section 7: Sixth Street Sixth Avenue. That the street heretofore designated and known as Sixth Street is hereby designated and renamed Sixth Avenue.
- Section 8: Seventh Street Seventh Avenue. That the street heretofore designated and known as Seventh Street is hereby designated and renamed Seventh Avenue.
- Section 9: Eighth Street Eighth Avenue. That the street heretofore designated and known as Eighth Street is hereby designated and renamed Eighth Avenue.
- Section 10: County Road Ninth Avenue. That that part of the county road forming and being a part of the south limits of the village is hereby designated and named Ninth Avenue.
- Section 11: F Street Ash Street. That the street heretofore designated and known as F Street is hereby designated and renamed Ash Street.
- Section 12: E Street Birch Street. That the street heretofore designated and known as E Street is hereby designated and renamed Birch Street.
- Section 13: <u>D Street Main Street</u>. That that part of the street heretofore designated and known as <u>D Street lying North</u> of the Public School is hereby designated and renamed Main Street.
- Section 14: <u>D Street Cherry Street</u>. That that part of the street heretofore designated and known as D Street lying South of the Public School is hereby designated and renamed Cherry Street.
- Section 15: C Street Douglas Street. That the street heretofore designated and known as C Street is hereby designated and renamed Douglas Street.

Section 16: B Street - Elm Street. That the street heretofore designated and known as B Street is hereby designated and renamed Elm Street.

Section 17: A Street - Fir Street. That the street heretofore designated and known as A Street is hereby designated and renamed Fir Street.

Section 18: Winona Street - Grove Street. That the street heretofore designated and known as Winona Street is hereby designated and renamed Grove Street.

Section 19: Park Street - Hemlock Street. That the street heretofore designated and known as Park Street is hereby designated and renamed Hemlock Street.

Section 20: <u>Laural Avenue - Ilex Street</u>. That the street heretofore designated and known as <u>Laural Avenue</u> is hereby designated and renamed Ilex Street.

Section 21: <u>Lincoln Avenue - Juniper Street</u>. That the street heretofore designated and known as Lincoln Avenue is hereby designated and renamed Juniper Street.

Section 22: Grand Avenue - Knott Street. That the street heretofore designated and known as Grand Avenue is hereby designated and renamed Knott Street.

Section 23: Effective Date: This Ordinance shall be in full force and effect from and after its passage and publication according to law.
